- 1) The “group” is responsible for returning the facility to its original set up when finished. Clean off tables, remove decorations, pick up trash on the floor & grounds, put trash in receptacles etc.
The security deposit will not be returned if the area is not acceptable.
- 2) We only provide the items mentioned, any other supplies needed must be provided by the group reserving the facility.
- 3) Propane grills may be brought in but must be located outside the pavilions.
- 4) Groups using the facility are expected to follow the Rules of the Park. (See attached)
- 5) Groups understand that they are entitled to exclusive use of the area they have reserved, but not the other park facilities, which are still open to the public.
- 6) **Tents:** Permission may be granted for the erection of a tent, however, the request **must** be made thru the park office **prior** to booking your reservation.
- 7) **Caterers:** If a caterer is to be used, the office *must* know in advance.
- 8) **Closing:** check with Park Attendant for closing time – all groups must be picked up & **ready to leave 30 minutes prior to closing.**
- 9) All pavilion users must read and follow ALL Lysander Park Rules & Regulations
- 10) **Bounce Houses** and **Water Sprayers** are not permitted.
- 11) The Town of Lysander reserves the right to deny use of any and all park facilities in subsequent years based upon problems encountered with anyone renting or invited to a park area.

Cancellation / Refund Policy / Bounced Checks

Full refund minus **(\$10.00)** Administrative Fee - Four weeks in advance.

Half refund minus **(\$10.00)** Administrative Fee - Two weeks in advance.

NO Refund - under 2 weeks or for inclement weather.

Bounced check fee is \$20.00, if not paid before event, reservation will be cancelled.

I hereby acknowledge that I have read, understand and agree to comply with the park’s rules and policies. I further verify that I am 21 years of age or older and assume responsibility for the above group. I understand the Town of Lysander is providing the above listed group with use of the designated area so long as park rules are obeyed and that the Town reserves the right to refuse use of a park area for any reason. **I have read & understand the park rules, in particular that NO ALCOHOL, WATER BALLOONS or DOGS are allowed in the park and that there is NO SMOKING in the pavilion areas, and will enforce this with my group.**
