## NOTICE OF SPECIAL ELECTION

### Town of Lysander, Onondaga County, New York

NOTICE IS HEREBY GIVEN that a special election of the Town of Lysander, Onondaga County, New York, will be held at the Lysander Town Hall, 8220 Loop Road, Baldwinsville, New York on the 4<sup>th</sup> day of May, 2018, at which the polls will be kept open between the hours of 12:00 P.M. and 9:00 P.M., for the purpose of voting by voting machine, on the adoption or rejection of a proposition with respect to a bond resolution dated and duly adopted January 18, 2018 by the Town Board of said Town.

The polls will be kept open for the purpose of voting during the aforesaid hours and the proposition to be voted upon will be in substantially the following form, to-wit:

#### PROPOSITION

Shall the bond resolution dated January 18, 2018, authorizing the issuance of up to \$400,000 bonds to construct a spray park facility in Lysander Town Park, at a maximum estimated cost of \$400,000, providing that the period of probable usefulness will be 15 years, that the maximum maturity of such bonds will exceed five years, delegating to the Supervisor the power to sell and issue such bonds and bond anticipation notes in anticipation of the issuance and sale of such bonds, pledging the faith and credit of the Town to the payment of the principal of and interest on such obligations, and providing for an estoppel provision, be approved?

NOTICE IS HEREBY FURTHER GIVEN that persons qualified to vote at such special election shall be qualified electors of the Town of Lysander, Onondaga County, New York.
