

**LEGAL NOTICE
ANNUAL ELECTION OF THE CODY FIRE DISTRICT
ON DECEMBER 11, 2018**

NOTICE IS HEREBY GIVEN, that the annual election of the Cody Fire District will take place on December 11th, 2018 between the hours of 6:00 P.M. and 9:00 P.M. at the Cody Fire District Station 1 located at 155 County Route 55, Fulton, NY 13069 for the purpose of electing one fire district commissioner for a five year term commencing on January 1, 2019 and ending on December 31, 2023. All voters who reside within the Cody Fire District, which is partially located in the Towns of Granby in Oswego County and Lysander in Onondaga County, who are residents of the fire district for at least 30 days prior to the date of the election and who have registered with the County Board of Elections in Onondaga County and Oswego County by the 19th day of November, 2018 shall be eligible to vote. Candidates for the Commissioner's Office shall have filed their names with the Secretary of the Cody Fire District, at the Cody Fire District Firehouse No. 1 at 155 County Route 55, Fulton, NY 13069 no later than 28 days before the election, by November 21st, 2018.

NOTICE IF HEREBY GIVEN, that the residents of the Cody Fire District shall also vote on December 11th, 2018 for the purpose of voting on the following proposition. Shall the Resolution of the Board of Fire Commissioners adopted on the 16th day of October, 2018 authorizing the establishment of a Capital Reserve Fund pursuant to General Municipal Law Section 6-g, (9) in the event of the acquisition of durable medical goods, including AED devices, portable suction units, backboards, Stokes recovery stretchers, and Lucas CPR devices, which Reserve Fund shall be in a separate bank account to be known as the "Durable Medical Goods Reserve Fund." The Fire District Treasurer is authorized to invest, from time to time, monies of this fund pursuant to Section 6-g, (9), of the General Municipal Law. No expenditure shall be made from this fund except upon authorization of the Board subject to a permissive referendum pursuant to Section 6-g, (7.) of the General Municipal Law.
