**NOTICE OF SPECIAL ELECTION OF THE VOTERS OF THE
NORTH WEST FIRE DISTRICT**

THE BOARD OF FIRE COMMISSIONERS OF THE NORTH WEST FIRE DISTRICT
HEREBY GIVES NOTICE that pursuant to a Bond Resolution adopted by the Board of Fire Commissioners of the Fire District on April 10 2018, a special election of the qualified voters of said Fire District, County of Onondaga, State of New York, will be held at Baldwinsville Station #3, 59 Elizabeth Street, in the Town of Lysander, Onondaga County, New York on May 8th, 2018 for the purpose of voting upon the following proposition:

PROPOSITION

Shall the Board of Fire Commissioners construct a new, two-story, approximately 13,000 square foot fire station on land owned by the Fire District at 117 Oswego Street, Baldwinsville, New York and make renovations and improvements and construct an approximately 4,470 square foot addition to Fire Station #1 located at 7911 Crego Road, Baldwinsville, New York including, for both, furnishings, fixtures and equipment incidental thereto and all other necessary incidental; expend therefore a total sum not to exceed \$4,534,150, levy a tax to pay the costs of the projects in the amount of \$4,534,150, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Fire Commissioners and in anticipation of the collection of such tax, shall bonds and notes of the Fire District be authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$4,534,150, and a tax approved to pay the interest on said obligations when due.

NOTICE IS GIVEN that voting upon the foregoing Proposition will be by paper ballot and will take place between the hours of 5:00 P.M. and 9:00 P.M., prevailing time.

NOTICE IS FURTHER GIVEN that the proposition set forth on the paper ballots shall appear as follows:

PROPOSITION

Shall the Board of Fire Commissioners construct a new, two-story, approximately 13,000 square foot fire station on land owned by the Fire District at 117 Oswego Street, Baldwinsville, New York and make renovations and improvements and construct an approximately 4,470 square foot addition to Fire Station #1 located at 7911 Crego Road, Baldwinsville, New York including, for both, furnishings, fixtures and equipment incidental thereto and all other necessary incidental; expend therefore a total sum not to exceed \$4,534,150, levy a tax to pay the costs of the projects in the amount of \$4,534,150, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Fire Commissioners and in anticipation of the collection of such tax, shall bonds and notes of the Fire District be authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$4,534,150, and a tax approved to pay the interest on said obligations when due.
