**NOTICE OF SPECIAL ELECTION OF THE VOTERS OF THE
NORTH WEST FIRE DISTRICT**

THE BOARD OF FIRE COMMISSIONERS OF THE NORTH WEST FIRE DISTRICT HEREBY GIVES NOTICE that pursuant to a Bond Resolution adopted by the Board of Fire Commissioners of the Fire District on August 7, 2015, a special election of the qualified voters of said Fire District, County of Onondaga, State of New York, will be held at Baldwinsville Station #1, 7911 Crego Road, in the Town of Lysander, Onondaga County, New York on September 22, 2015 for the purpose of voting upon the following propositions:

PROPOSITION I

Shall the Board of Fire Commissioners purchase Baldwinsville Fire Station #1 located at 7911 Crego Road, Baldwinsville, New York and Baldwinsville Fire Station #2 located at 7461 State Fair Boulevard, Baldwinsville, New York from the Baldwinsville Fire Department; expend therefore a total sum not to exceed \$2,065,407, levy a tax to pay the costs of the Fire Station purchases in the amount of \$2,065,407, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Fire Commissioners and in anticipation of the collection of such tax, shall bonds and notes of the Fire District be authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$2,065,407, and a tax approved to pay the interest on said obligations when due.

PROPOSITION II

If Proposition I passes, shall the Board of Fire Commissioners construct a new, one-story, approximately 10,505 square foot fire hall on approximately 6.75 acres of land owned by the Fire District in the Village of Baldwinsville at 104 Smokey Hollow Road and an approximately 5,100 square foot addition to Fire Station #1 located at 7911 Crego Road, Baldwinsville, New York, including for both, the furnishings, fixtures and equipment incidental thereto and all other necessary incidental costs; expend therefore a total sum not to exceed \$4,486,824, levy a tax to pay the costs of the construction and addition in the amount of \$4,486,824, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Fire Commissioners and in anticipation of the collection of such tax, shall bonds and notes of the Fire District be authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$4,486,824, and a tax approved to pay the interest on said obligations when due.

NOTICE IS GIVEN that voting upon the foregoing Propositions will be by paper ballot and will take place between the hours of 4:00 P.M. and 9:00 P.M., prevailing time.

NOTICE IS FURTHER GIVEN that the proposition set forth on the paper ballots shall appear as follows:

PROPOSITION I

Shall the Board of Fire Commissioners purchase Baldwinsville Fire Station #1 located at 7911 Crego Road, Baldwinsville, New York and Baldwinsville Fire Station #2 located at 7461 State Fair Boulevard, Baldwinsville, New York from the Baldwinsville Fire Department; expend therefore a total sum not to exceed \$2,065,407, levy a tax to pay the costs of the Fire Station purchases in the amount of \$2,065,407, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Fire Commissioners and in anticipation of the collection of such tax, shall bonds and notes of the Fire District be authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$2,065,407, and a tax approved to pay the interest on said obligations when due.
